# Terms & conditions & Privacy Policy

These Terms and Conditions ("Terms," "Terms and Conditions") govern your relationship with the soulect.com website (the "Service") operated by **Soulect Enterprises Inc.**, a Canadian corporation in B.C. ("us," "we," or "our").

Please read these Terms and Conditions carefully before using the Service.

## **Subscriptions**

Some parts of the Service are billed on a subscription basis ("Subscription(s)"), and you may be billed in advance and/or on a recurring and/or periodic basis ("Billing Cycle"). Billing cycles are usually set on a monthly basis.

A valid payment method, including credit card or PayPal, is required to process the payment for your Subscription. # Fee Changes

We, in our sole discretion and at any time, may modify the Subscription fees for the Subscriptions. Any Subscription fee change will become effective at the end of the then-current Billing Cycle.

We will provide you with a reasonable prior notice of any change in Subscription fees to give you an opportunity to terminate your Subscription before such change becomes effective.

Your continued use of the Service after the Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.

#### Refunds

After you've had the Soulect experience for 2 months (from your join date) and decide you don't want to continue, you can request a refund at soulectteam@gmail.com.

Your request must be received within exactly 2 months, which equates to 8 creator's circles, to be eligible for a refund.

Once you move into your 9th week, your initial 3-month membership is non-refundable.

After your initial 3-months, your membership will renew on a month-to-month basis. This you can cancel at anytime through an email request.
